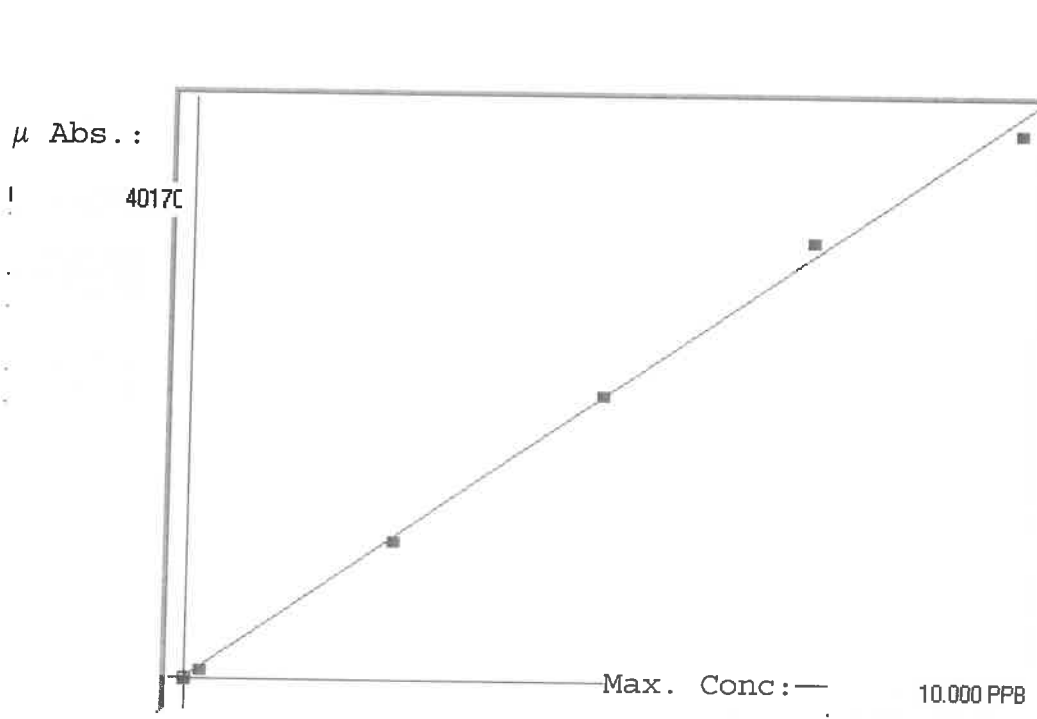

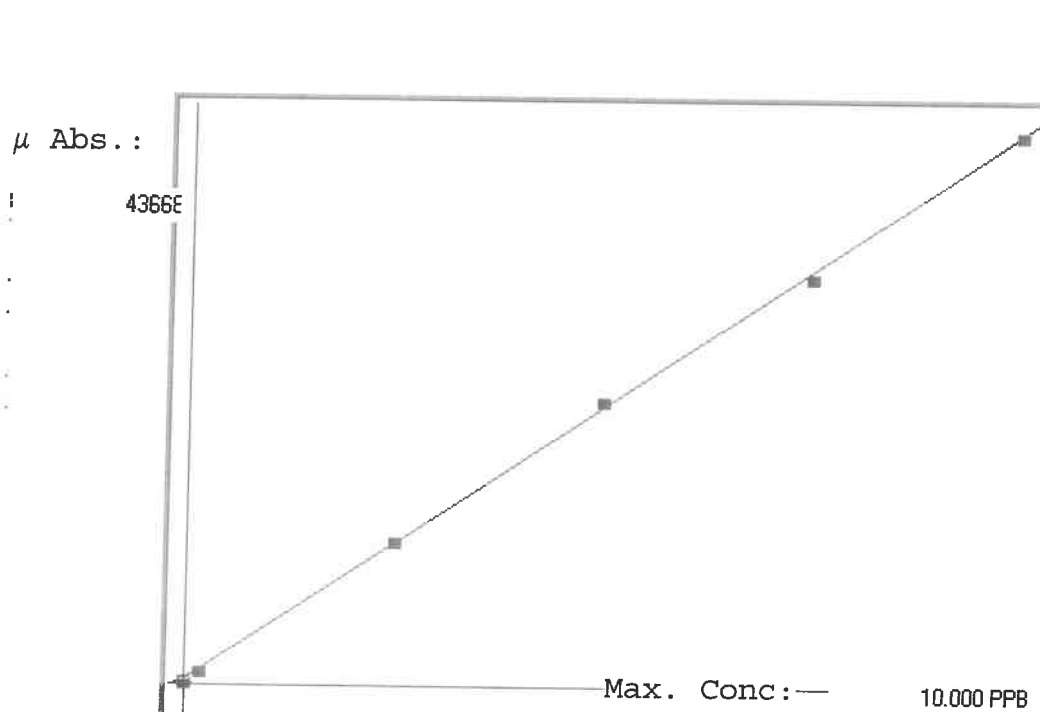

## 4.0 TRACEABILITY TO NIST
