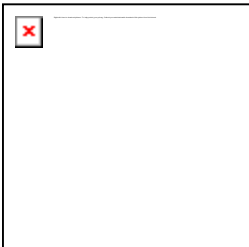
Issue: The COCs received at the laboratory do not include the CLP Case number.
