A. Number of Samples and Date of Receipt:

1 Solid sample was received on 11/27/2024.

B. Parameters:

According to the Chain of Custody document, the following analyses were requested: Mercury, Metals ICP-TAL and METALS-TAL. This data package contains results for Metals ICP-TAL.

C. Analytical Techniques:

The analysis of Metals ICP-TAL was based on method 6020B and digestion based on method 3050 (soils).

D. OA/ OC Samples:

The Holding Times were met for all analysis.

The Blank Spike met requirements for all samples.

The Duplicate (TAPIAL2-SB02D-13-112424-00-T1DUP) analysis met criteria for all samples except for Zinc due to sample matrix interference.

The Matrix Spike (TAPIAL2-SB02D-13-112424-00-T1MS) analysis met criteria for all samples except for Arsenic, Beryllium, Cadmium, Cobalt, Selenium, Silver and Vanadium due to Chemical Interference during digestion process.

The Matrix Spike Duplicate (TAPIAL2-SB02D-13-112424-00-T1MSD) analysis met criteria for all samples except for Arsenic, Beryllium, Cadmium, Cobalt, Selenium, Silver and Vanadium due to Chemical Interference during digestion process.

The Blank analysis did not indicate the presence of lab contamination.

The Calibration met the requirements.

The Serial Dilution (TAPIAL2-SB02D-13-112424-00-T1L) met criteria for all samples except for Nickel due to sample matrix interference.

E. Additional Comments:

P5241-01 sample analyzed Straight X5 dilution because of high interferent samples.

Collision cell is being used to remove potential interferences. The analytes Na. Mg. Al. K, V, Cr, Mn, Fe, Co, Ni, Cu, Zn, As are being analyzed with collision cell and analytes Be, B, Ca, Ti, Se, Sr, Zr, Mo, Ag, Cd, Sn, Sb, Ba, Tl, Pb, U are being analyzed with Non-Collision Cell. Helium gas is used for the Collision Cell analysis.
