The MS {Q1422-01MS} with File ID: BF141784.D recoveries met the requirements for all compounds except for 3,3-Dichlorobenzidine[63%], 3-Nitroaniline[49%] and 4-Chloroaniline[26%], Recovery is failing due to matrix interference therefor not further corrective action was required.
