C. Analytical Techniques:

The analysis of pH was based on method 9045D and The analysis of TOC was based on method 9060A.

D. QA/ QC Samples:

The Holding Times were met for all samples except for TAPIAL2-SED03-031125-00-T2 of pH, for TAPLPR-SED12-031125-00-T2 of pH.for TAPLPR-SED13-031125-00-T2 of pH as samples were receive out of holding time.

The Blank Spike met requirements for all samples.

The Duplicate analysis met criteria for all samples.

The Matrix Spike analysis met criteria for all samples.

The Matrix Spike Duplicate (TAPLPR-SED13-031125-00-T2MSD) analysis met criteria for all samples except for TOC due to matrix interferences.

The Blank analysis did not indicate the presence of lab contamination.

The Calibration met the requirements.
