C. Analytical Techniques:

The analysis of TPH was based on method 1664A, The analysis of TSS was based on method SM2540 D and The analysis of BOD5 was based on method SM5210 B.

The Holding Times were met for all samples except for COMP of BOD5 as samples were analyzed out of holding time.

The Blank Spike met requirements for all samples.

The Duplicate analysis met criteria for all samples.
