The Continuous Calibration File ID BF142640.D met the requirements except for 4-Nitrophenol is marginally biased Low and Bis(2-ethylhexyl)phthalate and Di-n-octyl phthalate failed high side but associated samples does not have hit for these compound, therefor no further corrective action was taken.

The Continuous Calibration File ID BF142748.D met the requirements except for 2,4-Dinitrophenol is marginally biased Low, therefor no further corrective action was taken. The Tuning criteria met requirements.

Samples TP-26 was diluted due to dirty and viscous matrix.

E. Additional Comments:

The Form 6 is not included in the data package because the Initial Calibration was performed using 7 points.

The soil samples results are based on a dry weight basis.
