The Blank Spike met requirements for all samples.

The Duplicate analysis met criteria for all samples.

The Matrix Spike (LAW-25-0084MS) analysis met criteria for all samples except for TKN due to matrix interference.

The Matrix Spike Duplicate (LAW-25-0084MSD) analysis met criteria for all samples except for TKN due to matrix interference.

The Blank analysis did not indicate the presence of lab contamination.
