The MSD {Q2734-01MSD} with File ID: BF143314.D recoveries met the requirements for all compounds except for 3,3-Dichlorobenzidine[50%], 3-Nitroaniline[62%], 4,6-Dinitro-2-methylphenol[40%], 4-Chloroaniline[26%], This compound did not meet the NJDKQP criteria but met the in-house criteria.

For Hexachlorocyclopentadiene[0%], Fluoranthene[200%], Pyrene[145%], Benzo(b)fluoranthene[136%], This compound did not meet the NJDKQP criteria and in-house criteria due to matrix interference.

The RPD for {Q2734-01MSD} with File ID: BF143314.D met criteria except for 2,4-Dinitrophenol[46%], 4,6-Dinitro-2-methylphenol[32%], RPD failed due to result difference between MS and MSD , Therefore no further corrective action was taken..

The Blank Spike for {PB169095BS} with File ID: BF143307.D met requirements for all compounds except for 3,3-Dichlorobenzidine[65%], 3-Nitroaniline[65%] and 4-Chloroaniline[54%]. This compound did not meet the NJDKQP criteria but met the in-house criteria.

The Blank analysis did not indicate the presence of lab contamination.
The %RSD is greater than 20% for certain compounds in the Initial Calibration (Method 8270-BF071725.M) for 2,4-Dinitrophenol, 4,6-Dinitro-2-methylphenol this Compound is passing on Linear Regression.

The Continuous Calibration File ID BF143305.D met the requirements except for 4-Nitrophenol. Compound is failing high but associated sample does not have hit for this compound, therefor no further corrective action was taken

The Tuning criteria met requirements.

The Form 6 is not included in the data package because the Initial Calibration was performed using 7 points.
