C. Analytical Techniques:

The analysis of Oil and Grease,TPH was based on method 1664A, The analysis of pH was based on method 9040C, The analysis of TSS was based on method SM2540 D and The analysis of BOD5 was based on method SM5210 B.

D. QA/ QC Samples:

The Holding Times were met for all samples except for DRAIN-WATER-TANK-1 of pH as sample was receive out of holding time.

The Blank Spike met requirements for all compounds.

The Duplicate analysis met criteria for all compounds.

The Matrix Spike analysis met criteria for all compounds.

The Matrix Spike Duplicate analysis met criteria for all compounds.

The Blank analysis did not indicate the presence of lab contamination.
