C. Analytical Techniques:

The analysis of Oil and Grease was based on method 1664A and The analysis of COD was based on method SM5220 D.

D. QA/ QC Samples:

The Holding Times were met for all analysis.

The Blank Spike met requirements for all compounds.

The Duplicate analysis met criteria for all compounds.

The Matrix Spike analysis met criteria for all compounds.

The Matrix Spike Duplicate analysis met criteria for all compounds.

The Blank analysis did not indicate the presence of lab contamination.

The Calibration met the requirements.

E. Additional Comments:

As per method 1664A, MS/MSD is required to be performed with the sample analysis. However, Lab did not receive sufficient volume to perform the MS/MSD for Q3218 therefore Lab reported MS-MSD from Q3229.

Sample Q3218-01 and Q3218-03 were analyzed straight Dilution for COD because the original samples were reading over range, only 10X and 5X has been reported. The temperature of the samples at the time of receipt was 20.4°C.
