#### A. Number of Samples and Date of Receipt:

1 Water sample was received on 10/23/2025.

#### **B.** Parameters

According to the Chain of Custody document, the following analyses were requested: Metals Group4, Anions Group1, BOD5, COD, pH, Phosphorus-Total, TKN, Total Nitrogen, TSS. This data package contains results for Metals Group4(6010D), Anions Group1(300.0), BOD5(SM5210 B), COD(SM5220 D), pH(9040C), Phosphorus-Total(365.3), TKN(SM4500 N Org B or C), Total Nitrogen(Cal), TSS(SM2540 D).

#### C. Analytical Techniques:

Metals Group4: The analysis of Metals Group4 was based on method 6010D and digestion based on method 3010 (waters).

Wetchem: The analysis of Anions Group1 was based on method 300.0, The analysis of Phosphorus-Total was based on method 365.3, The analysis of pH was based on method 9040C, The analysis of Total Nitrogen was based on method Cal, The analysis of TSS was based on method SM2540 D, The analysis of TKN was based on method SM4500 N Org B or C, The analysis of BOD5 was based on method SM5210 B and The analysis of COD was based on method SM5220 D.

#### D. QA/ QC Samples:

The Holding Times were met for all analysis except following Wetchem: SW-1 of BOD5, Nitrite, Nitrate and pH as sample was receive out of holding time.

The MS recoveries met the requirements for all compounds.

The MSD recoveries met the acceptable requirements.

The RPD recoveries met criteria.

The Blank Spike met requirements for all compounds.

The Blank analysis did not indicate the presence of lab contamination.
