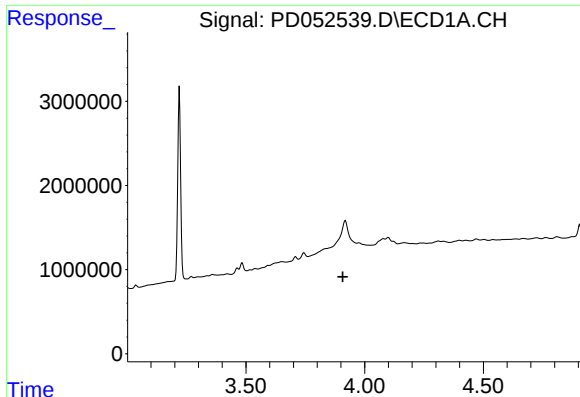
#2 alpha-BHC

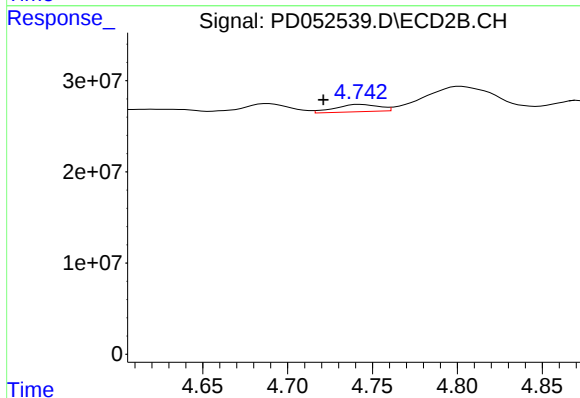

#3 gamma-BHC (Lindane)

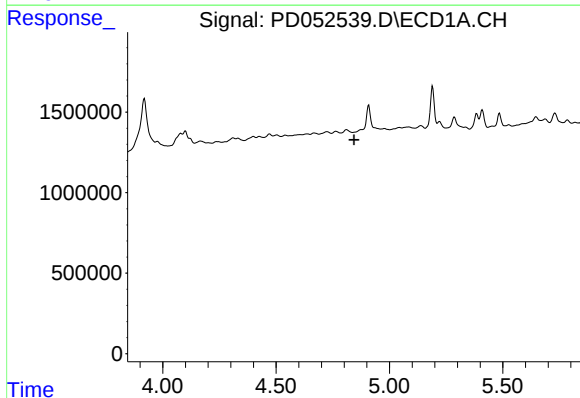

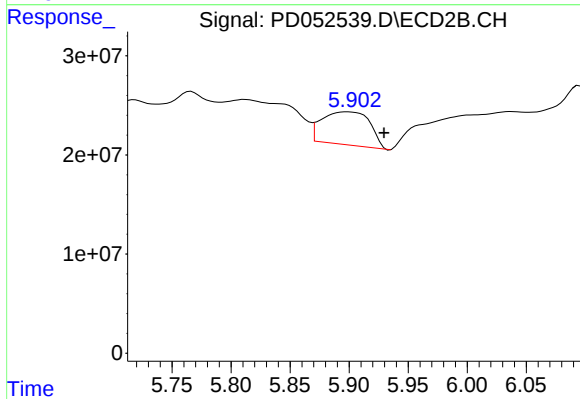
#3 gamma-BHC (Lindane)

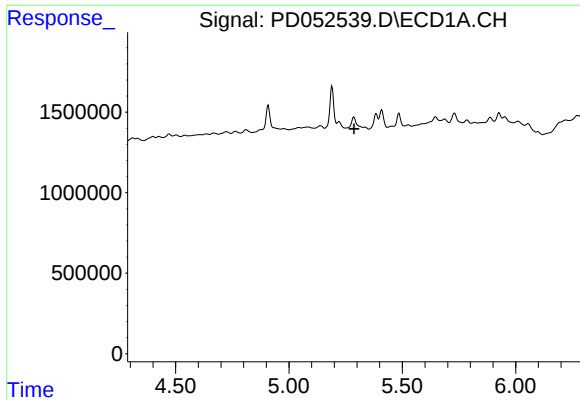
#8 Heptachlor epoxide

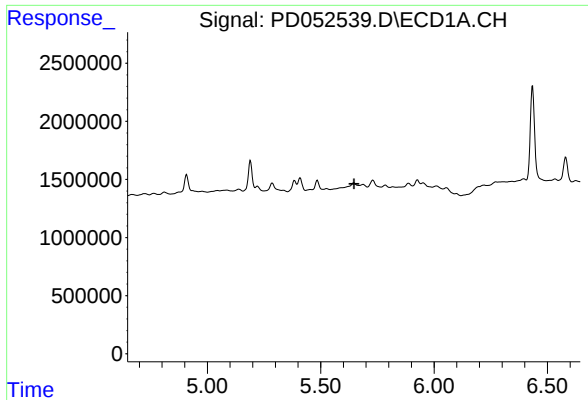
#13 Dieldrin

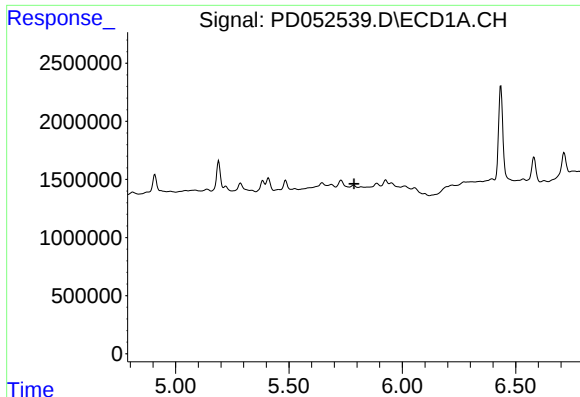
#15 Endosulfan II

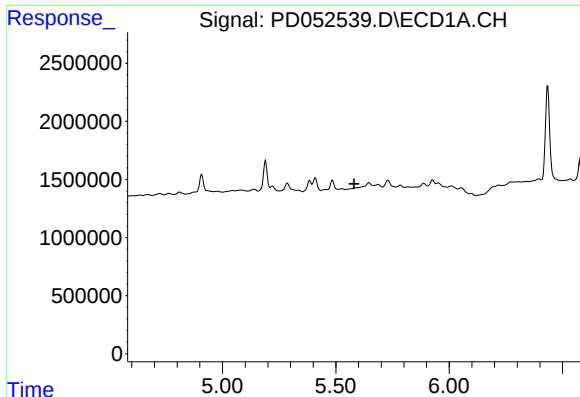
#22 Toxaphene-1

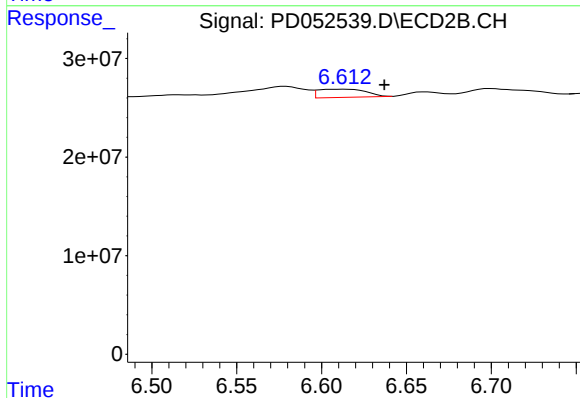

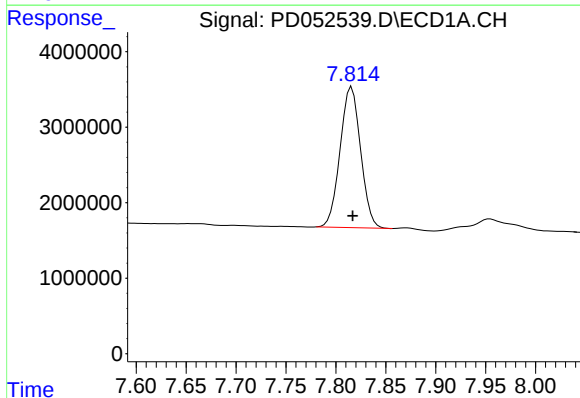

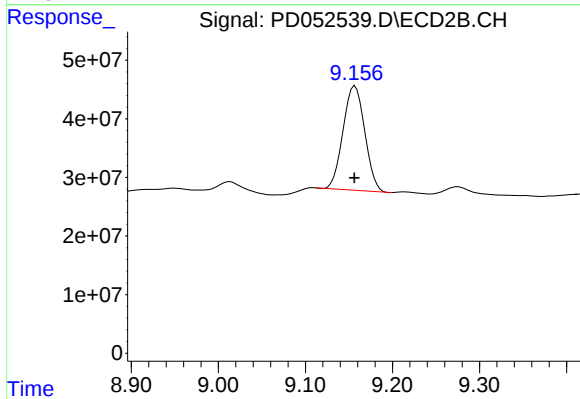
#23 Toxaphene-2
