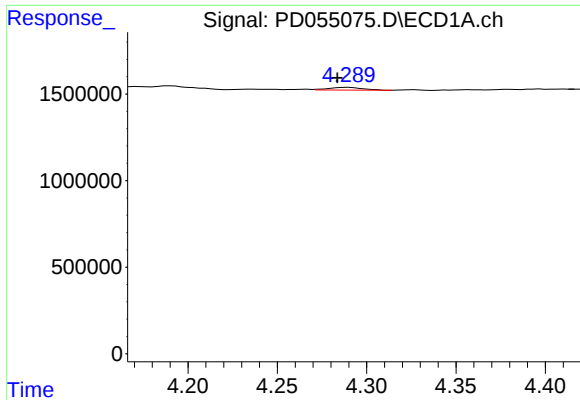
#3 gamma-BHC (Lindane)

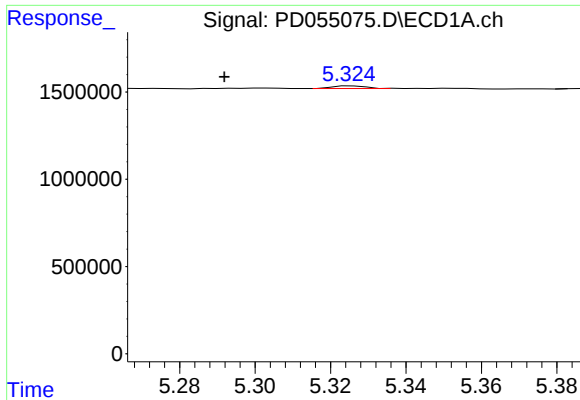
#6 beta-BHC

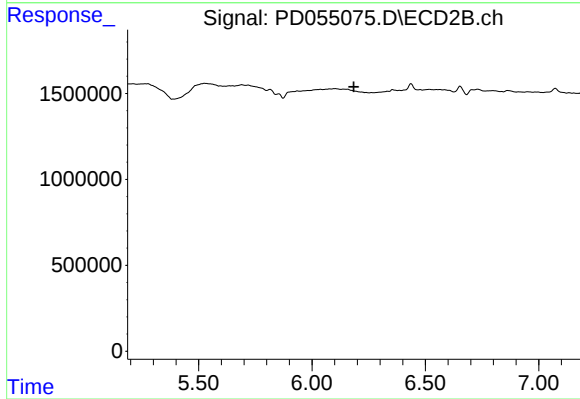

#9 Endosulfan I

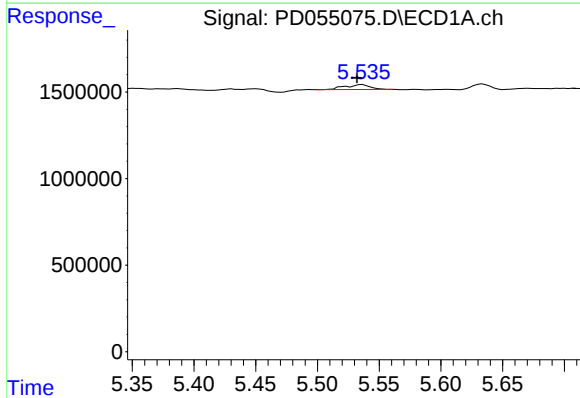

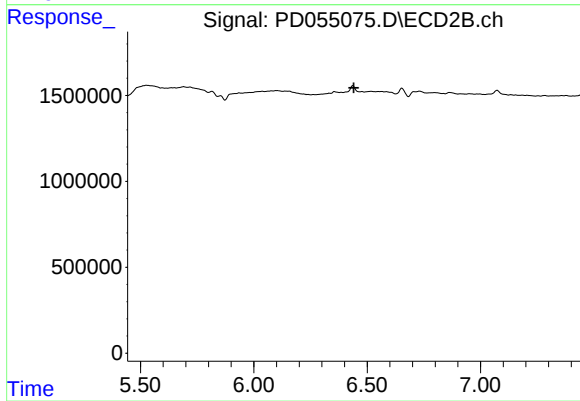

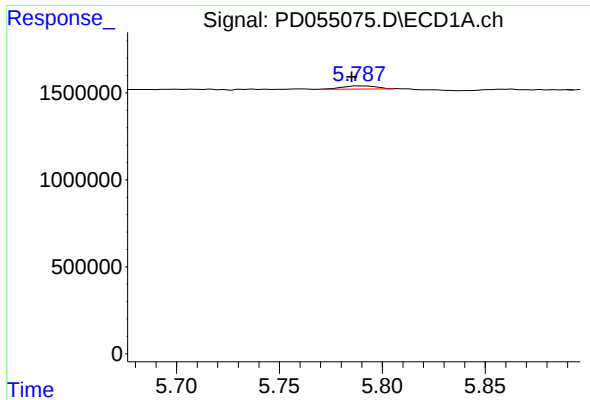
#13 Dieldrin

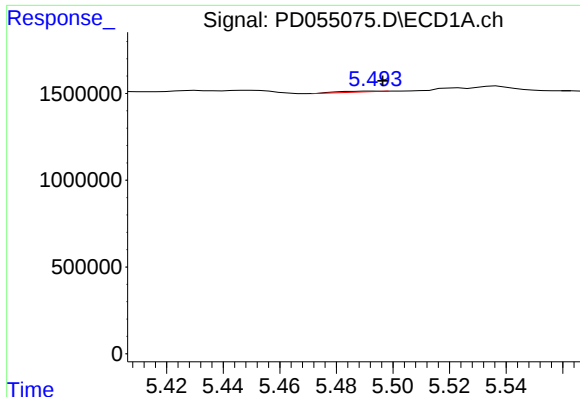
#20 Methoxychlor

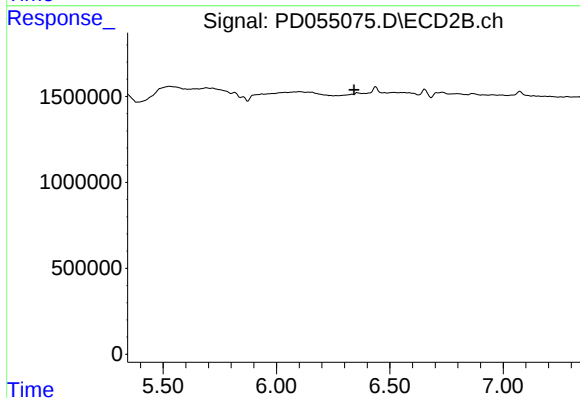

#22 Toxaphene-1

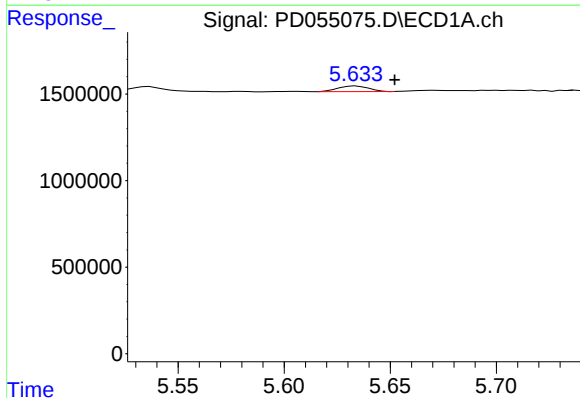

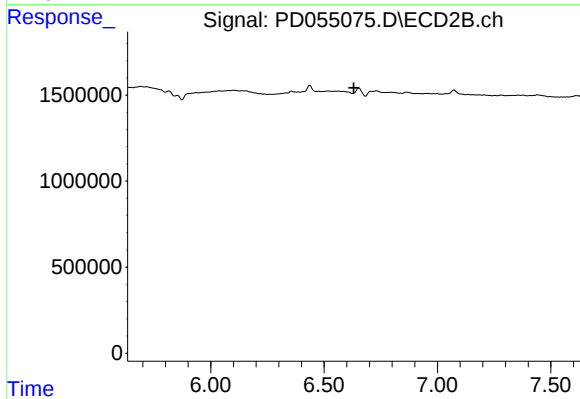

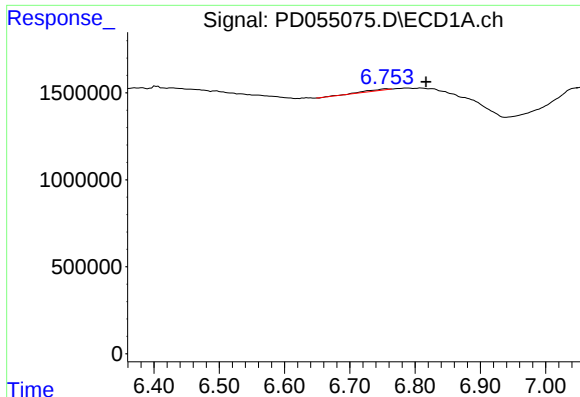
#23 Toxaphene-2

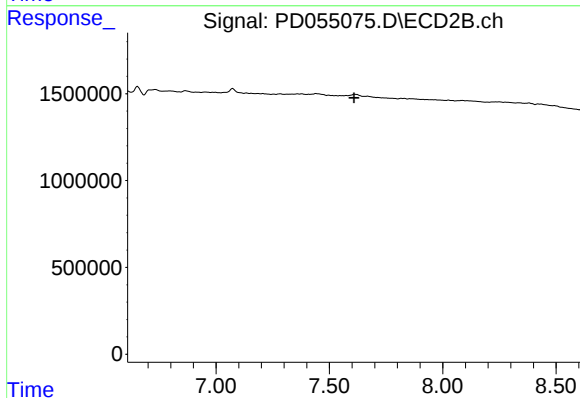

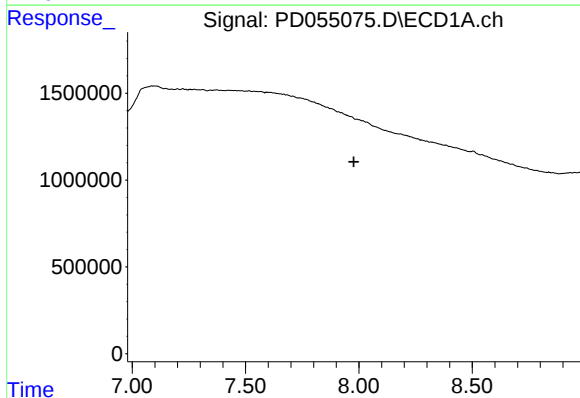

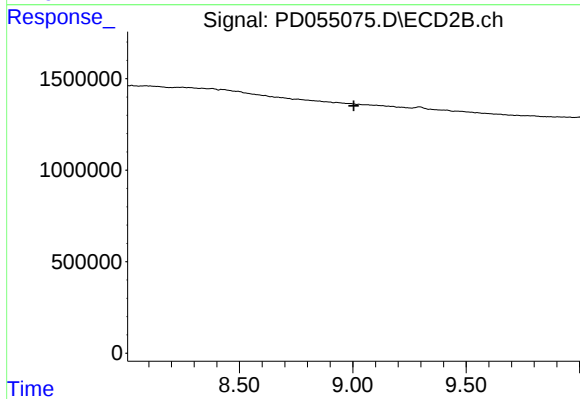
