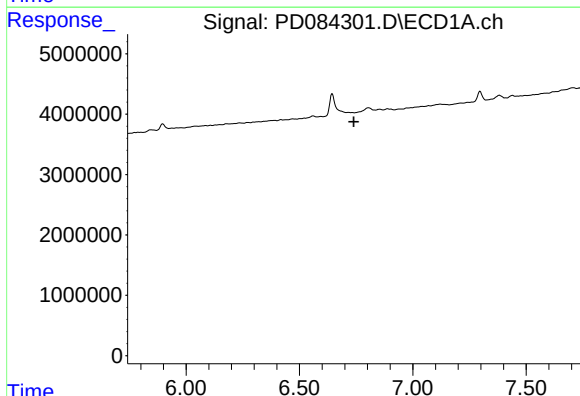

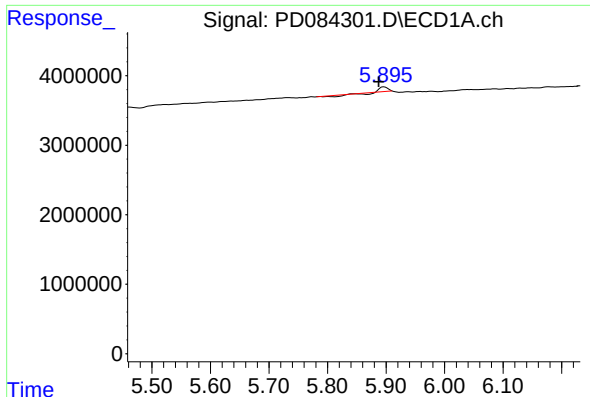
#16 4,4'-DDD

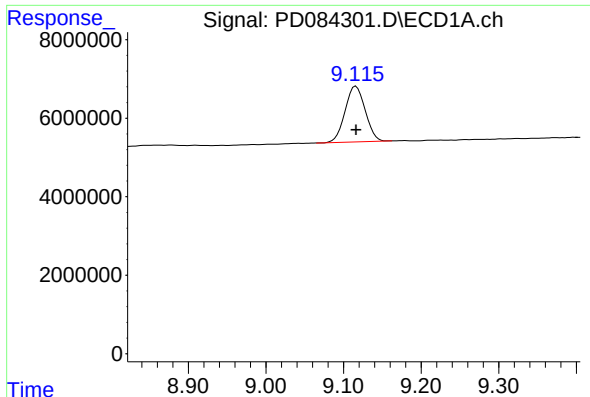
#24 Toxaphene-3

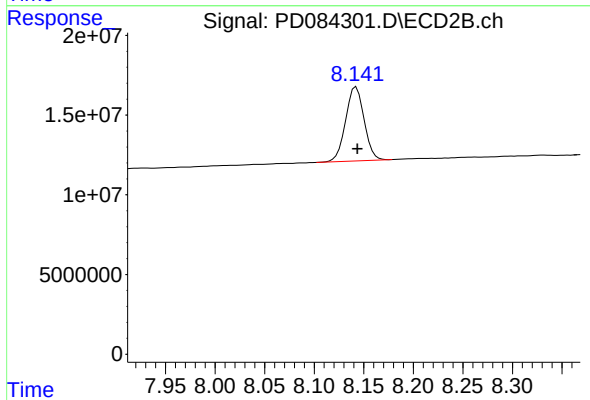
