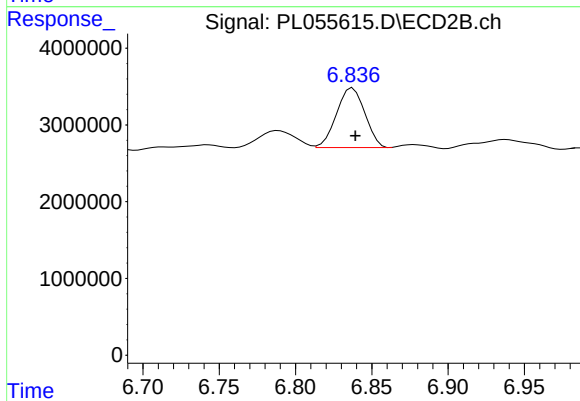
#1 Tetrachloro-m-xylene

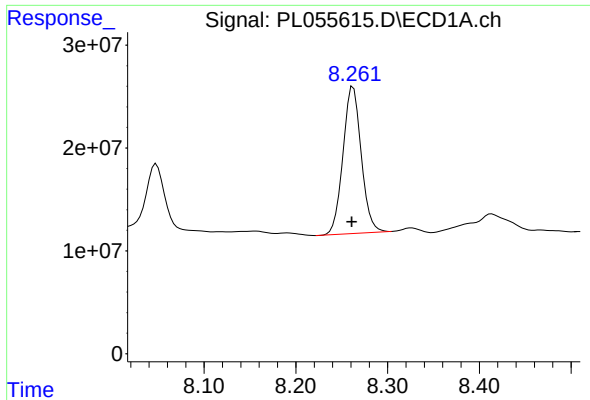
#16 4,4'-DDD

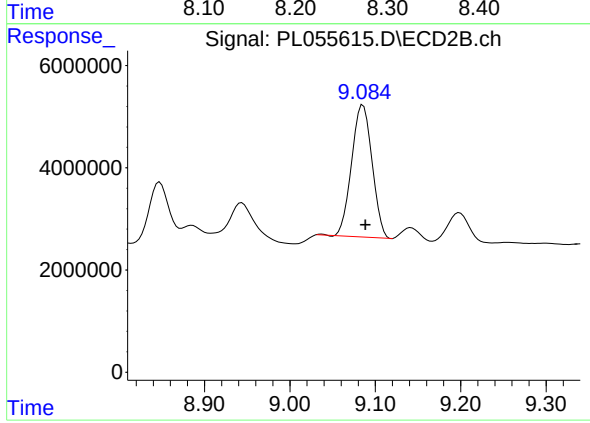
#28 Decachlorobiphenyl
