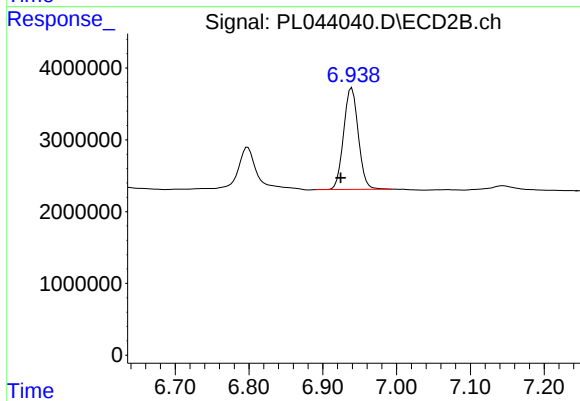
#1 Tetrachloro-m-xylene

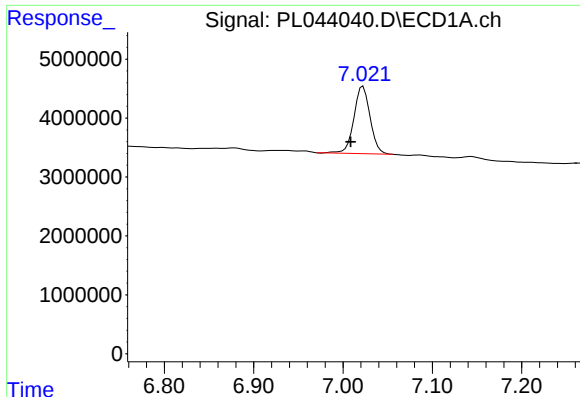
#15 Endosulfan II

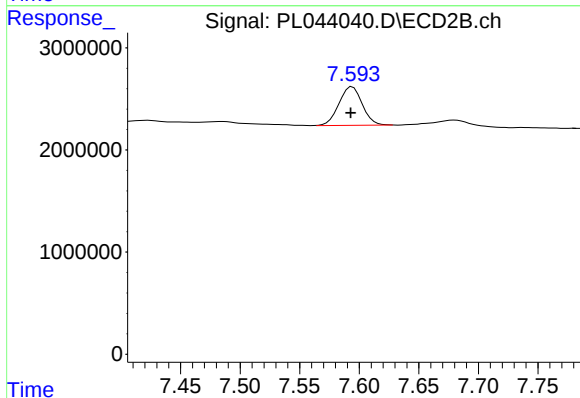

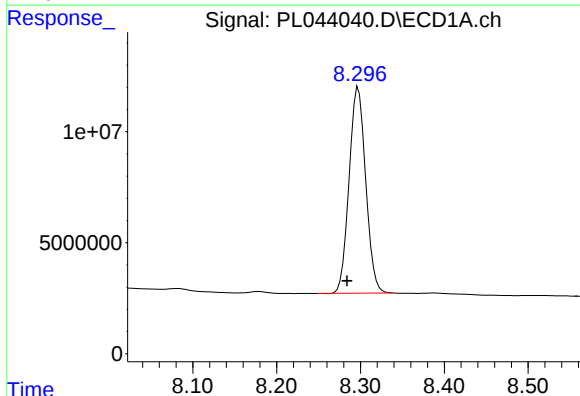

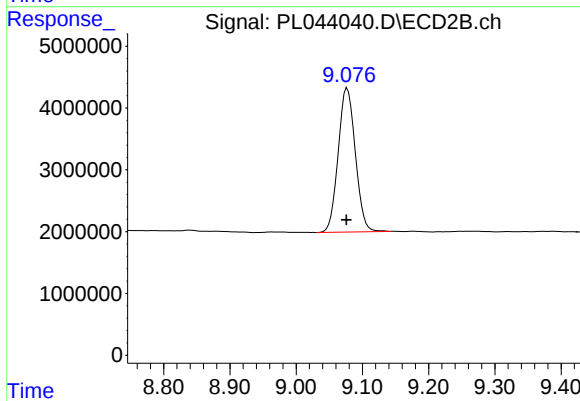
#20 Methoxychlor
