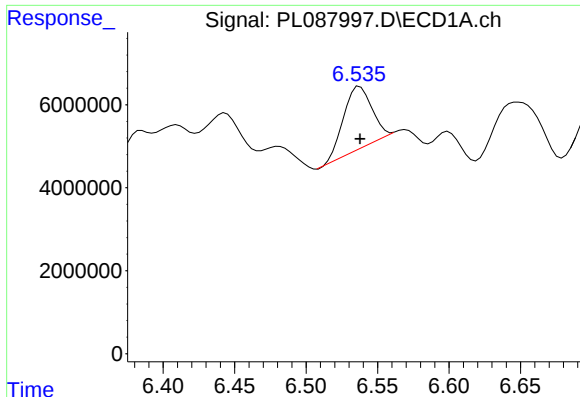
#2 Toxaphene-1
