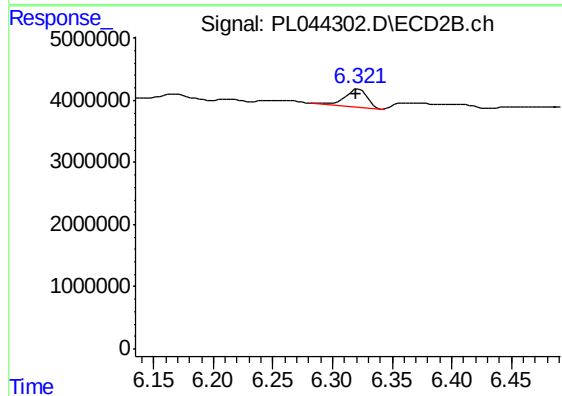
#1 Tetrachloro-m-xylene

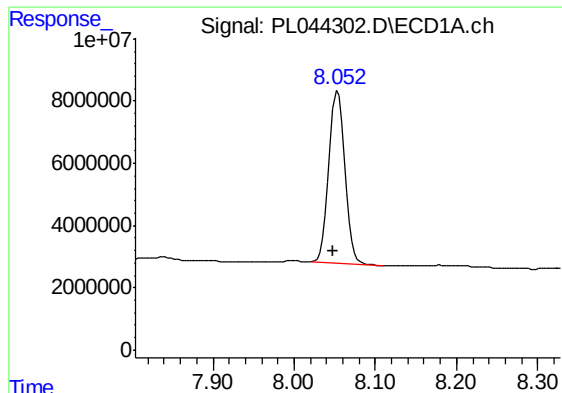
#12 4,4'-DDE

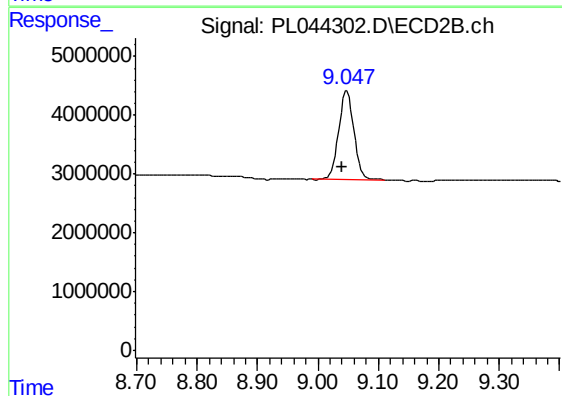
#28 Decachlorobiphenyl
