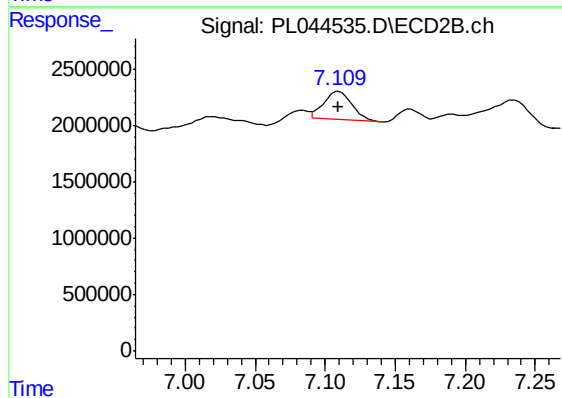
#1 Tetrachloro-m-xylene

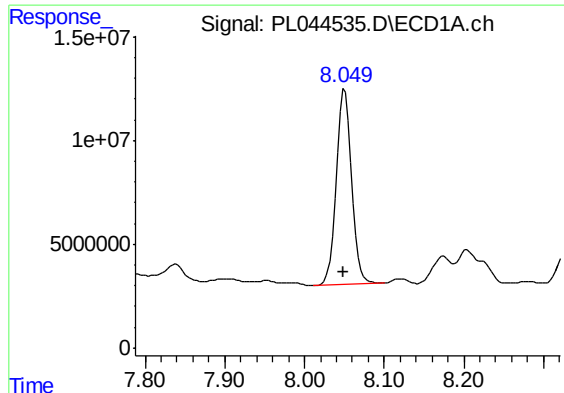
#17 4,4'-DDT

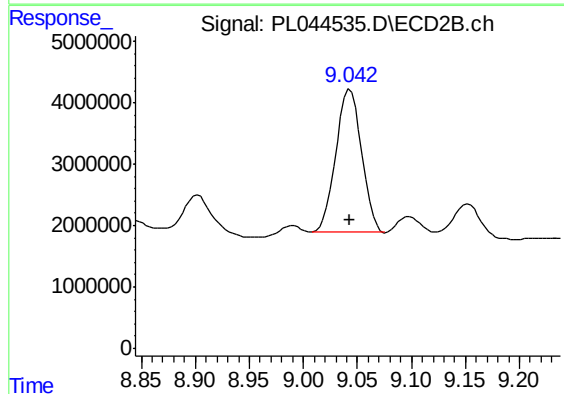
#28 Decachlorobiphenyl
