#12 4,4'-DDE

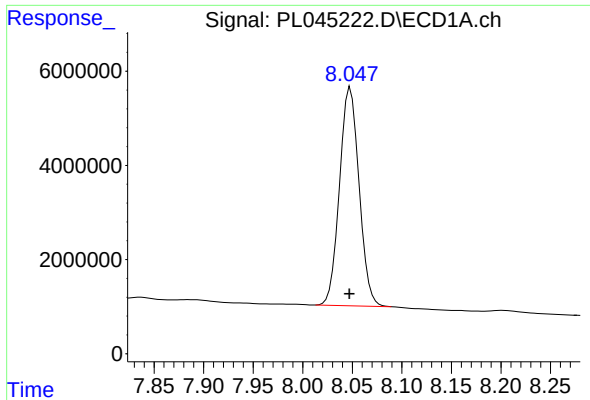

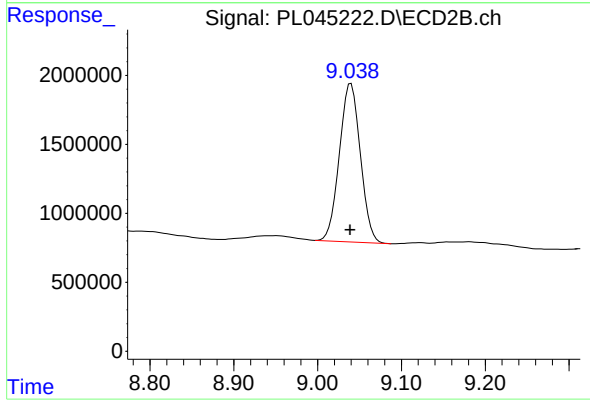


#28 Decachlorobiphenyl
