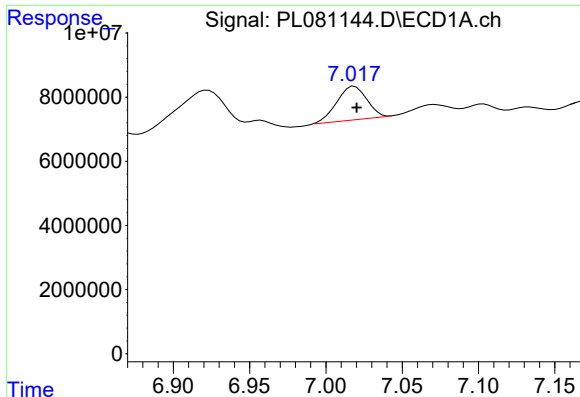
#4 Toxaphene-3
