#8 Heptachlor epoxide

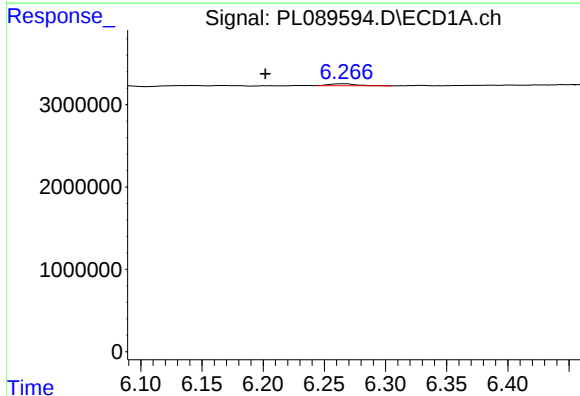

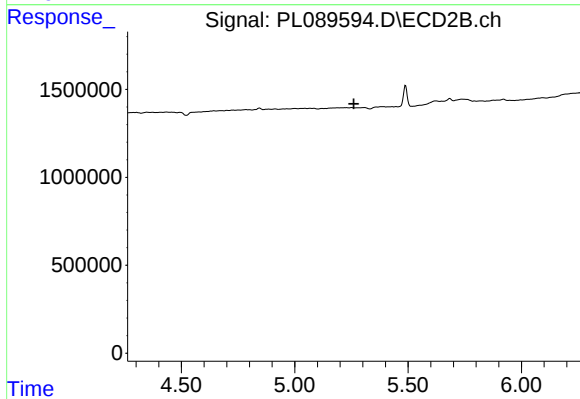

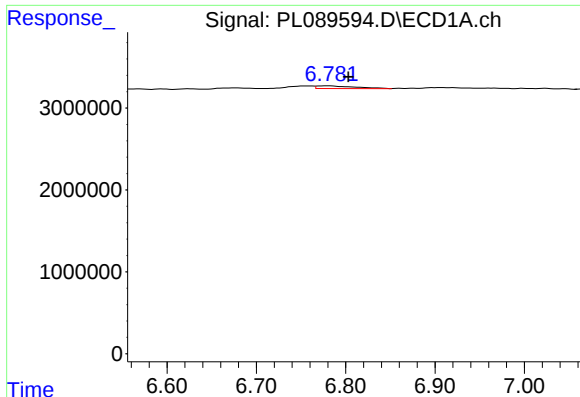
#12 4,4'-DDE

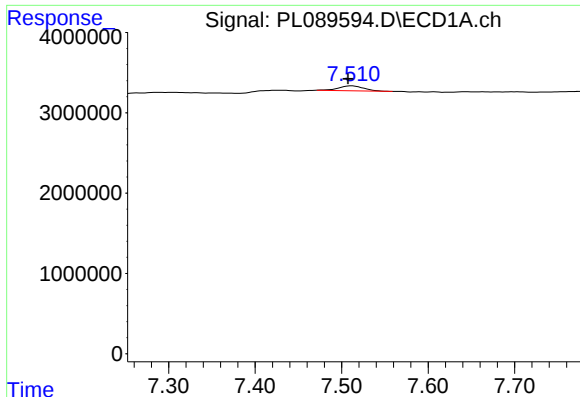
#16 4,4'-DDD

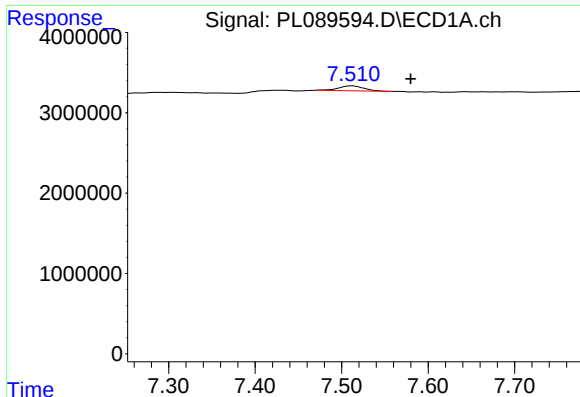
#22 Toxaphene-1

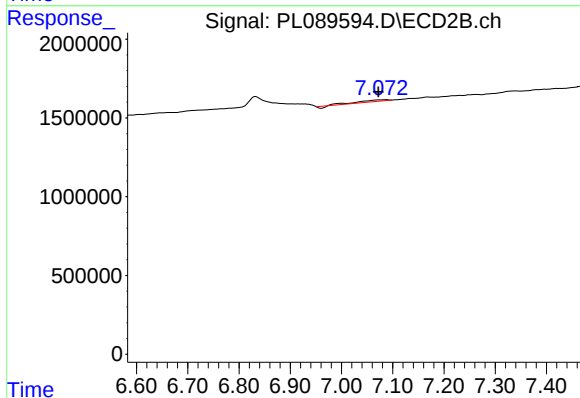

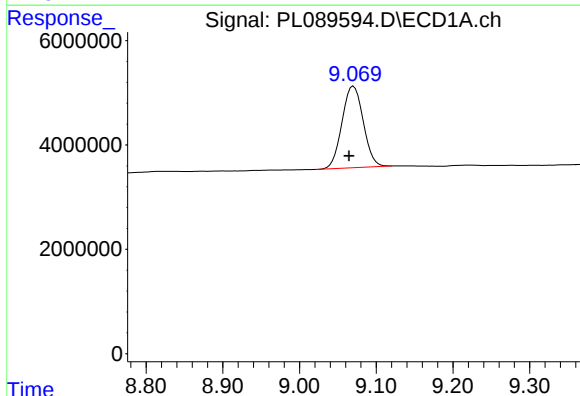

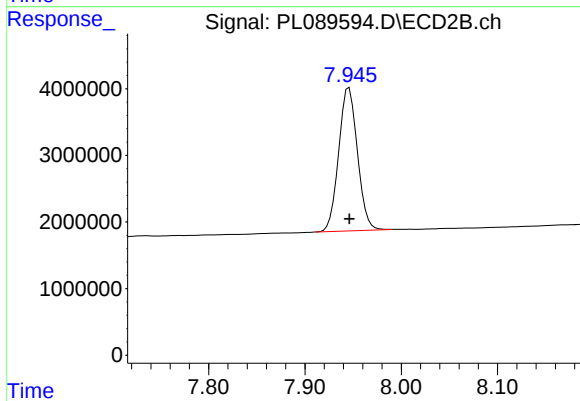
