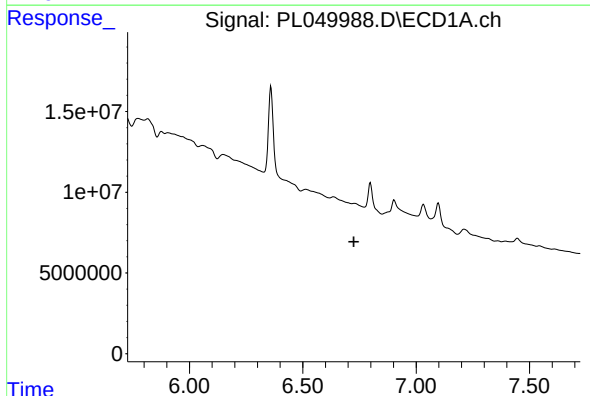

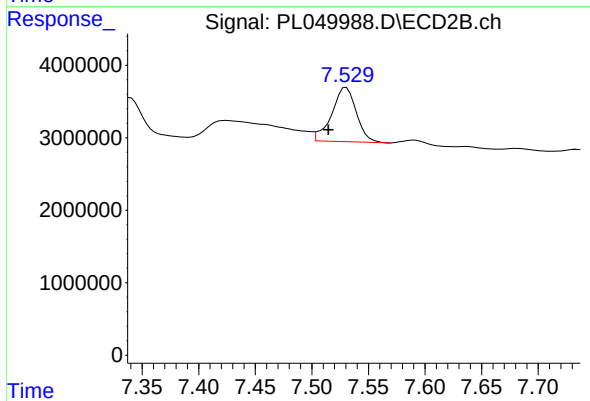

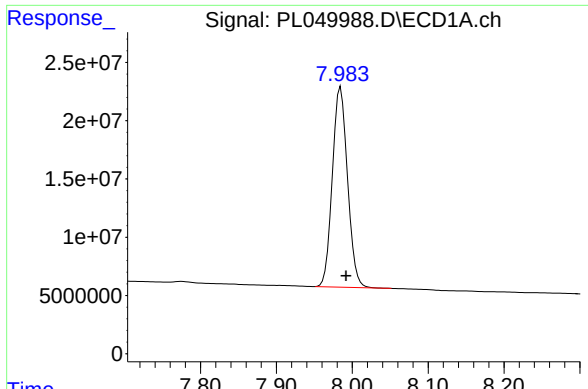
#20 Methoxychlor

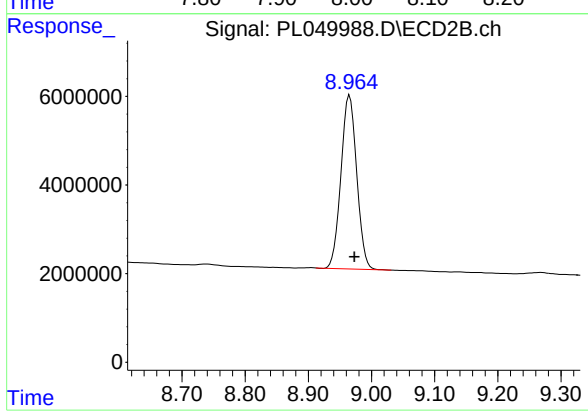
