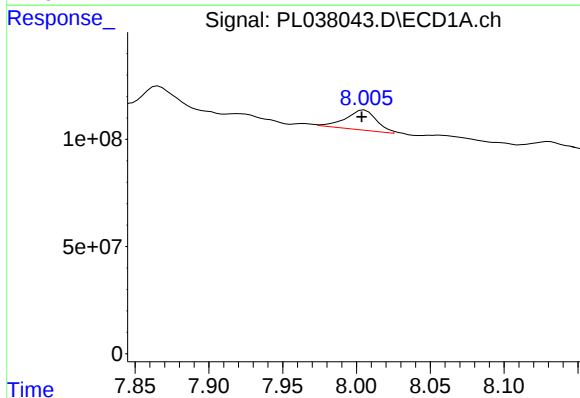
#1 Tetrachloro-m-xylene

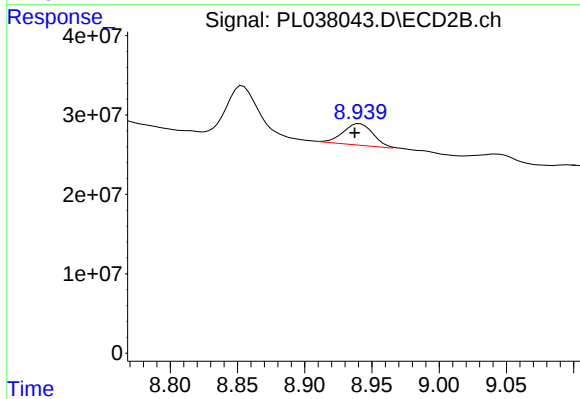
#28 Decachlorobiphenyl
