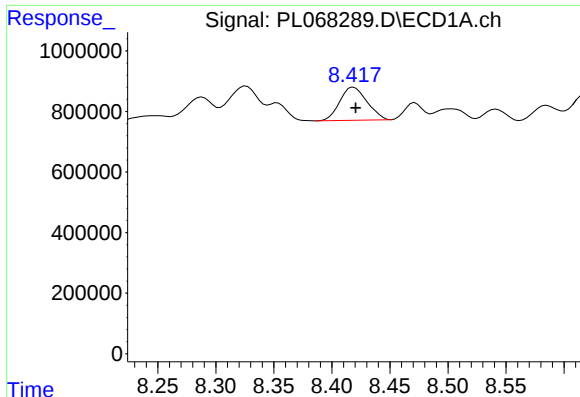
#2 Toxaphene-1

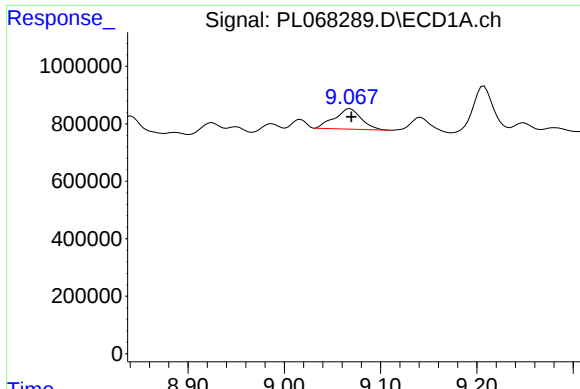
#4 Toxaphene-3

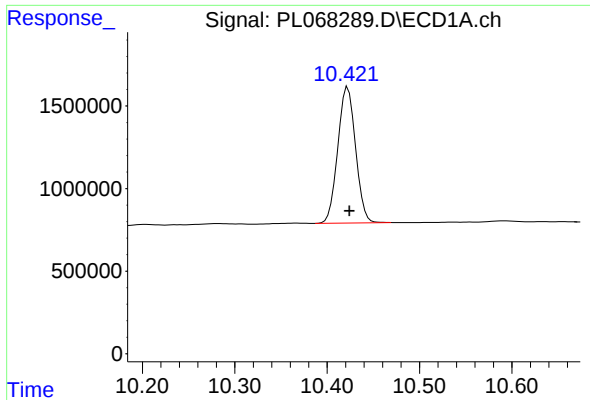
#6 Toxaphene-5

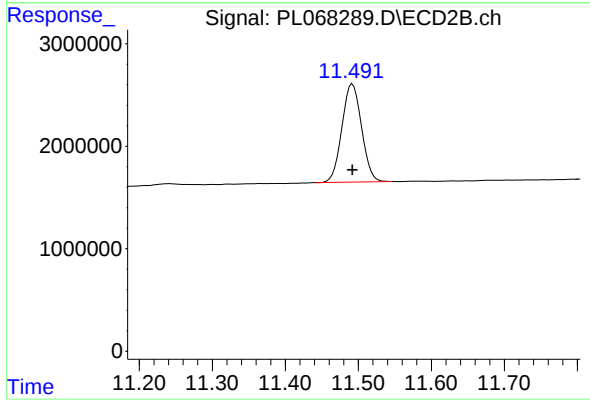
