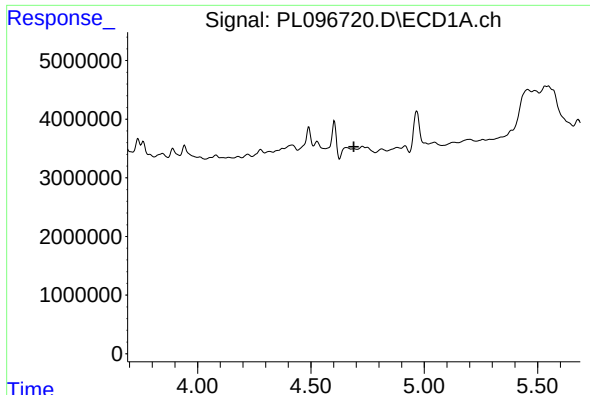
#19 Endosulfan Sulfate

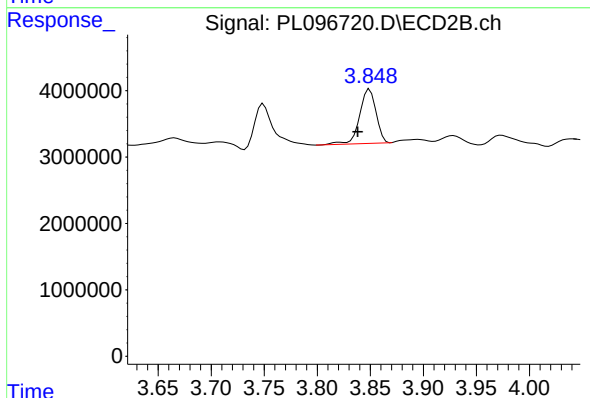

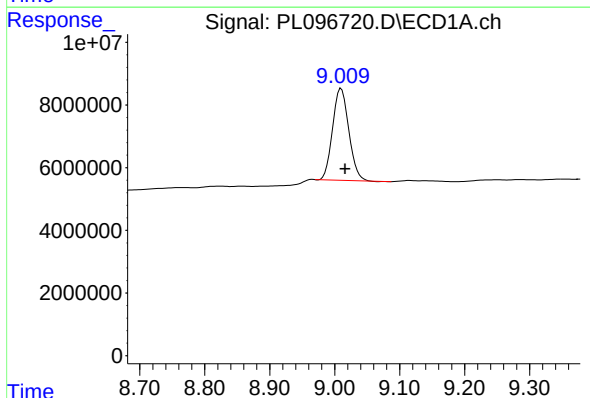

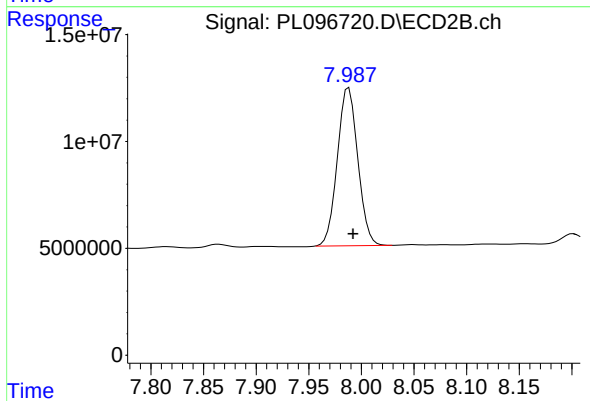
