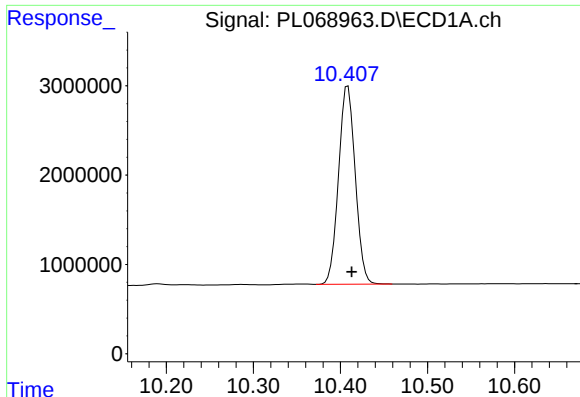
#6 Toxaphene-5

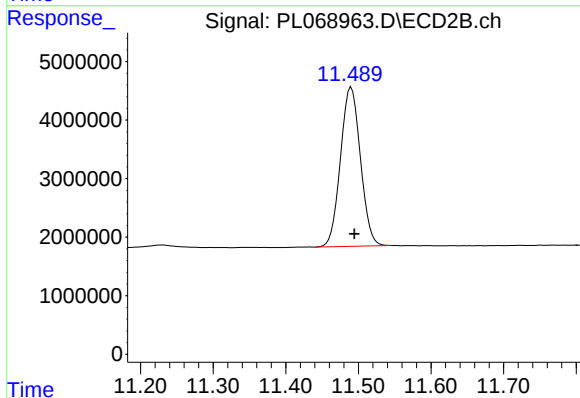
