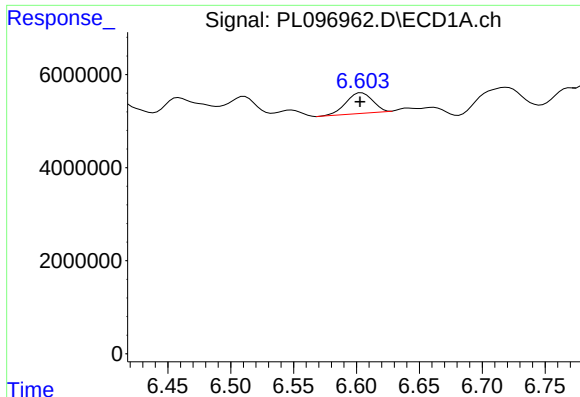
#2 Toxaphene-1

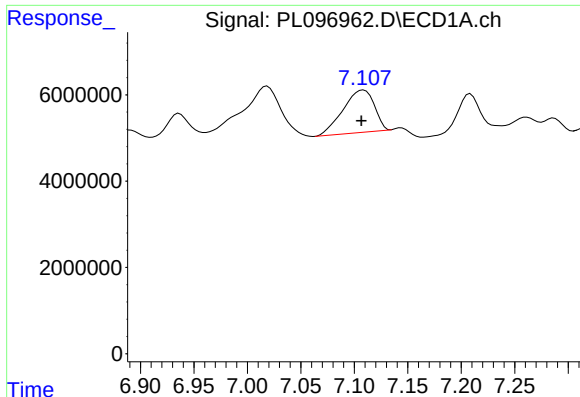
#4 Toxaphene-3
