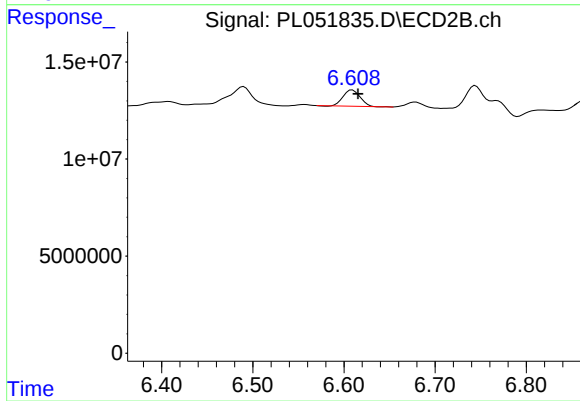
#1 Tetrachloro-m-xylene

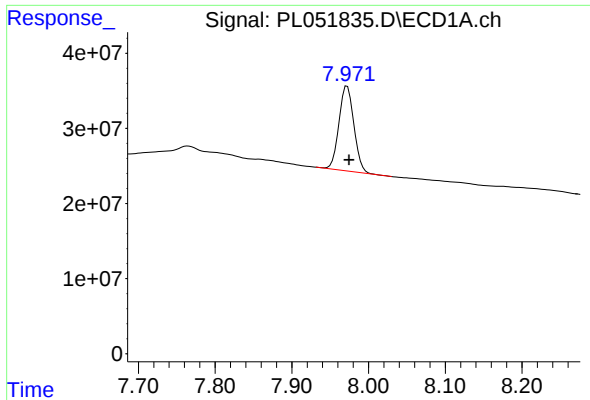
#14 Endrin

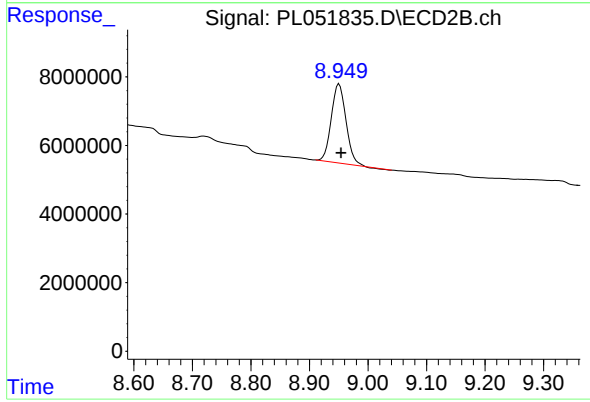
#28 Decachlorobiphenyl
