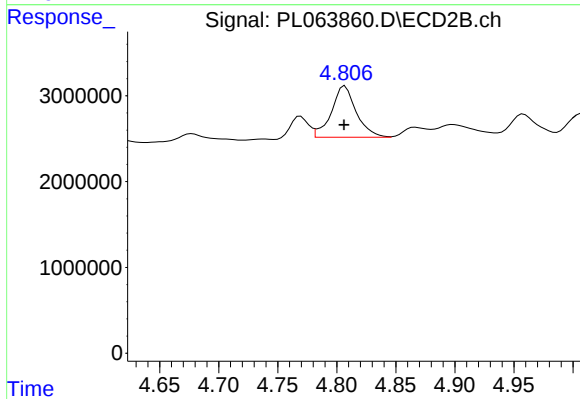
#1 Tetrachloro-m-xylene

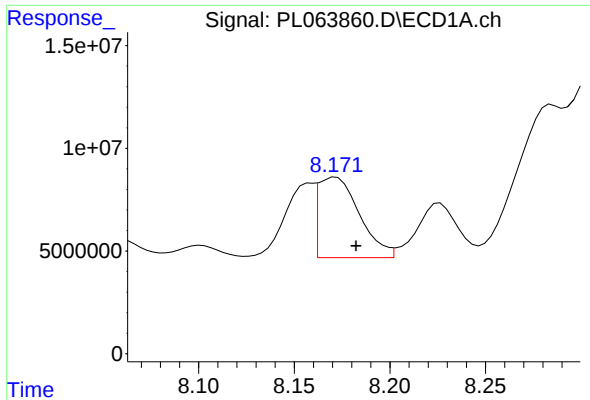
#3 gamma-BHC (Lindane)

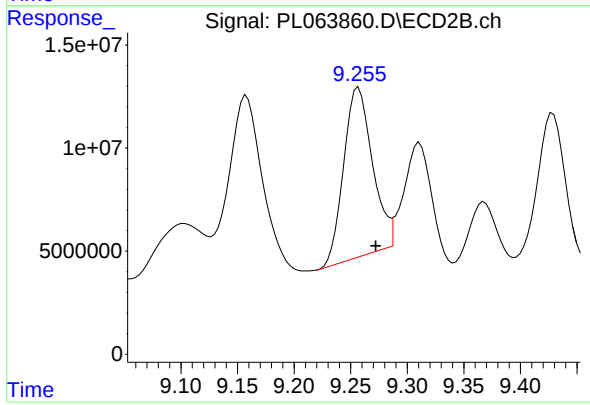
#28 Decachlorobiphenyl
