A. Number of Samples and Date of Receipt:

6 Solid samples were received on 03/29/2023.

B. Parameters

According to the Chain of Custody document, the following analyses were requested: Cyanide, Mercury, Metals ICP-TAL, PCB, Pesticide-TCL, SVOC-TCL BNA -20, TCL+30/TAL, TPH GC and VOC-TCLVOA-10. This data package contains results for Pesticide-TCL.

C. Analytical Techniques:

The analysis was performed on instrument ECD_L. The front column is ZB-MR2 which is 30 meters, 0.32 mm ID, 0.25 um df, Catalog #: 7HMG017- 11 The rear column is ZB-MR1 which is 30 meters, 0.32 mm ID, 0. 5 um df,: Catalog # 7HM-G016-17. .The analysis of Pesticide-TCLs was based on method 8081B and extraction was done based on method 3541.

D. QA/ QC Samples:

The Holding Times were met for all analysis.

The Surrogate recoveries met the acceptable criteria.

The Retention Times were acceptable for all samples.

The MS recoveries met the requirements for all compounds.

The MSD recoveries met the acceptable requirements.

The RPD met criteria.

The Blank Spike met requirements for all samples.

The Blank analysis did not indicate the presence of lab contamination.

The Initial Calibration met the requirements.

The Continuous Calibration met the requirements.

Samples RS-A, RS-E was diluted due to bad matrix.

Sample RS-D was diluted due to high concentration.

E. Additional Comments:

The soil samples results are based on a dry weight basis.

Samples RS-A, RS-E were dark brown in matrix, therefore as precautionary measure lab has analyzed these samples with straight 10X dilution. Due to sample nature, it was not plausible for lab to run these samples undiluted.
