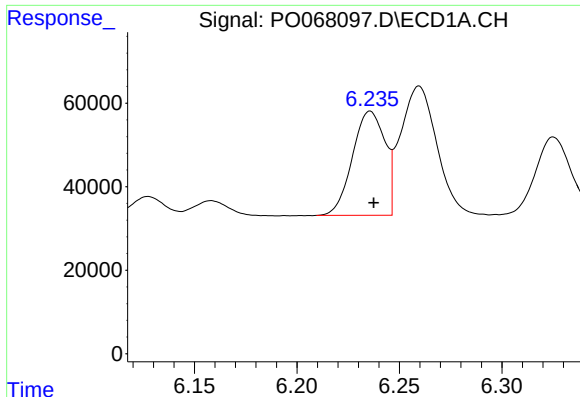
#2 Decachlorobiphenyl
