### A. Number of Samples and Date of Receipt:

24 Solid samples were received on 05/14/2022.

#### **B.** Parameters

According to the Chain of Custody document, the following analyses were requested: Cyanide, Mercury, Metals ICP-TAL, METALS TAL+CN, PCB, Pesticide-TCL and SVOC-TCL BNA -20. This data package contains results for PCB.

### **C. Analytical Techniques:**

The analyses were performed on instrument GCECD\_P. The front column is ZB-MR1 which is 30 meters, 0.32 mm ID, 0.5 um df, Catalogue # 7HM-G016-17. The rear column is ZB-MR2 which is 30 meters, 0.32 mm ID, 0.25  $\mu$ m; Catalogue # 7HM-G017-11.The analyses were performed on instrument GCECD\_O. The front column is ZB-MR1 which is 30 meters, 0.32 mm ID, 0.5 um df, Catalogue # 7HM-G016-17. The rear column is ZB-MR2 which is 30 meters, 0.32 mm ID, 0.25  $\mu$ m; Catalogue # 7HM-G017-11.The analysis of PCBs was based on method 8082A and extraction was done based on method 3541.

#### **D. QA/ QC Samples:**

The Holding Times were met for all analysis. The Surrogate recoveries met the acceptable criteria except for P007-SS010-2430-01 [Decachlorobiphenyl(1) - 276%, Decachlorobiphenyl(2) - 225%], P007-SS010-2430-01DL [Decachlorobiphenyl(1) - 0%, Decachlorobiphenyl(2) - 0%, Tetrachloro-m-xylene(1) - 0%, Tetrachloro-m-xylene(2) - 0%], P007-SS011-0612-01DL [Decachlorobiphenyl(1) - 0%, Decachlorobiphenyl(2) - 0%, Tetrachloro-m-xylene(1) - 0%, Tetrachloro-m-xylene(2) - 0%], P007-SS012-0612-01DL [Decachlorobiphenyl(1) - 0%, Decachlorobiphenyl(2) - 0%, Tetrachloro-m-xylene(1) - 0%, Tetrachloro-m-xylene(2) - 0%], P007-SS013-0612-01DL [Decachlorobiphenyl(1) - 0%, Decachlorobiphenyl(2) - 0%, Tetrachloro-m-xylene(1) - 0%, Tetrachloro-m-xylene(2) - 0%], P007-SS013-1218-01 [Decachlorobiphenyl(1) - 174%], P007-SS013-1824-01MS [Decachlorobiphenyl(1) - 177%], P007-SS013-1824-01MSD [Decachlorobiphenyl(1) - 180%] and P007-SS014-0006-01 [Decachlorobiphenyl(1) - 167%].

The Retention Times were acceptable for all samples.

The MS recoveries met the requirements for all compounds.

The MSD recoveries met the acceptable requirements.

The RPD met criteria.

The Blank Spike met requirements for all samples.

The Blank analysis did not indicate the presence of lab contamination. The Initial Calibration met the requirements.

The Continuous Calibration File ID PO086452.D met the requirements except for Aroclor-1260(Peak-04,05),Decachlorobiphenyl is failing in 2nd column but passing in average criteria.

Samples P007-SS010-1824-01, P007-SS010-2430-01, P007-SS011-0006-01, P007-SS011-0612-01, P007-SS011-1218-01, P007-SS012-0612-01, P007-SS012-1218-01 and P007-SS012-1824-01 were diluted due to high concentrations.

# **E. Additional Comments:**

The soil samples results are based on a dry weight basis.

# F. Calculation for Concentration in Soil samples:

Concentration ug/Kg (Dry weight basis) = (Ax) (Vt) (DF) (GPC)(CF) (Vi) (Ws) (D)

Where,

Ax = Response (peak area or height) of the compound to be measured.

CF = Mean Calibration Factor from the initial calibration (area/ng).

Vt = Volume of the concentrated extract in uL

Vi = Volume of extract injected (uL). (If a single injection is made onto two columns, use  $\frac{1}{2}$  the volume in the syringe as the volume injected onto each column).

Ws = Weight of sample extracted (g).

D = % dry weight or <u>100 - % Moisture</u> 100

 $GPC = Vin_{Vout} = GPC \text{ factor (If no GPC is performed, GPC=1)}$ Vout DF = Dilution Factor
