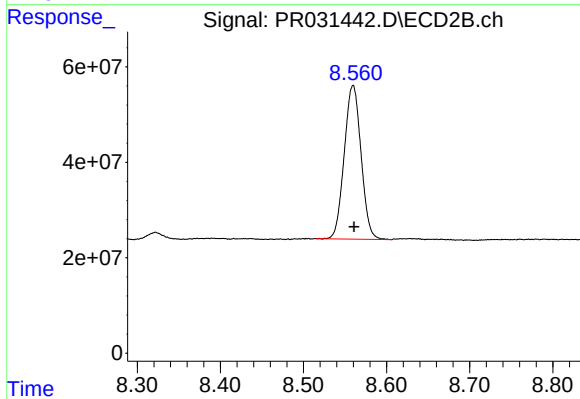
#1 Tetrachloro-m-xylene
