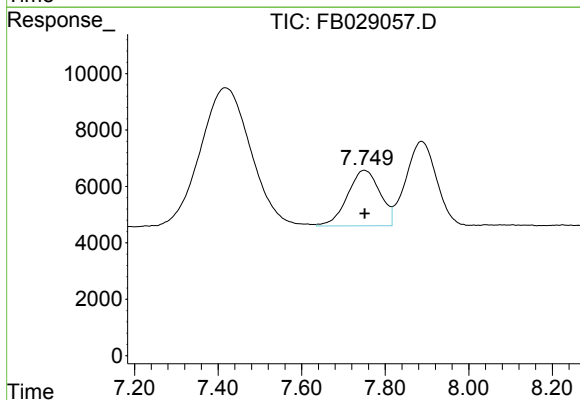

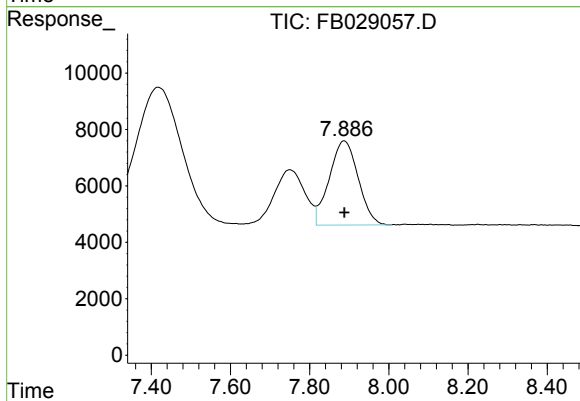
#2 2,2,4-Trimethylpentane

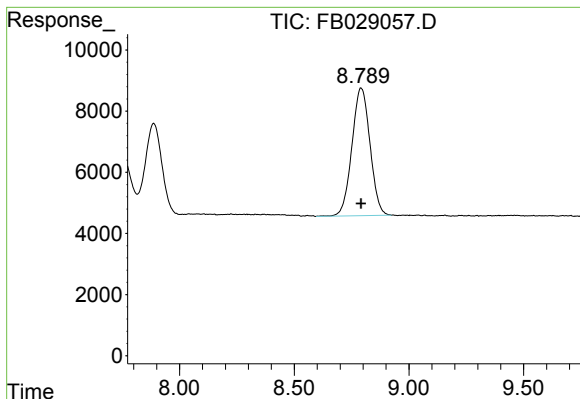
#3 n-Heptane

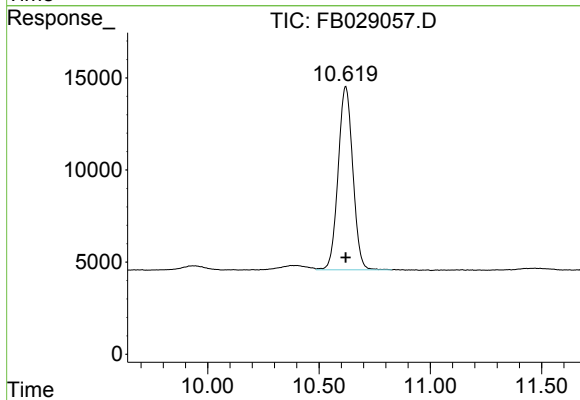

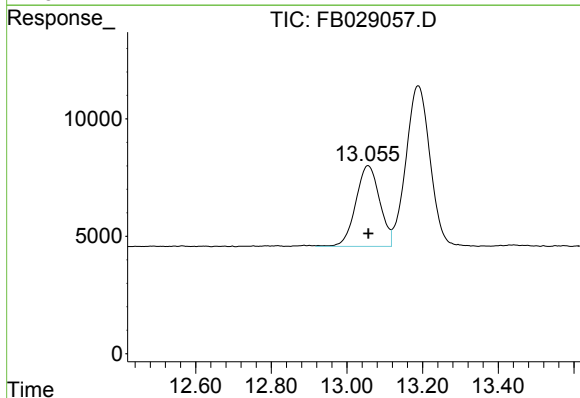

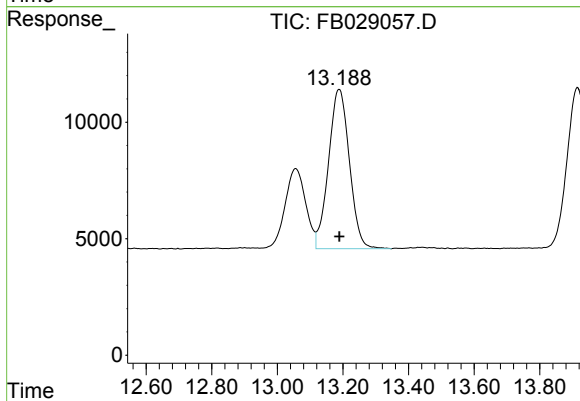
#6 Toluene

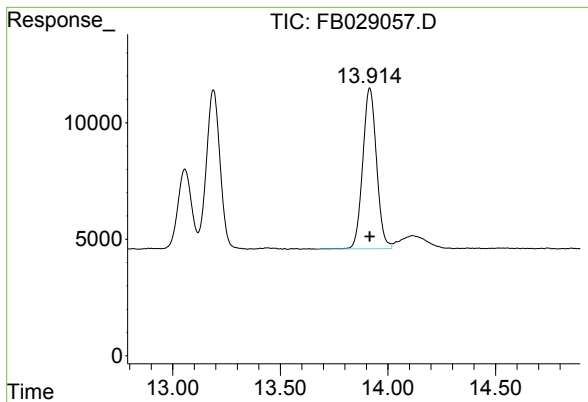
#7 Ethylbenzene

#8 m-Xylene

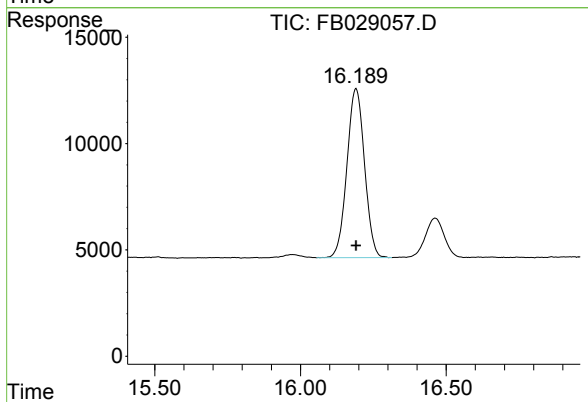
