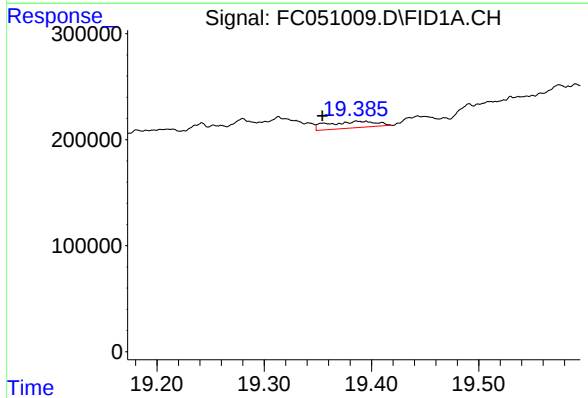
#9 ortho-Terphenyl (SURRE)
