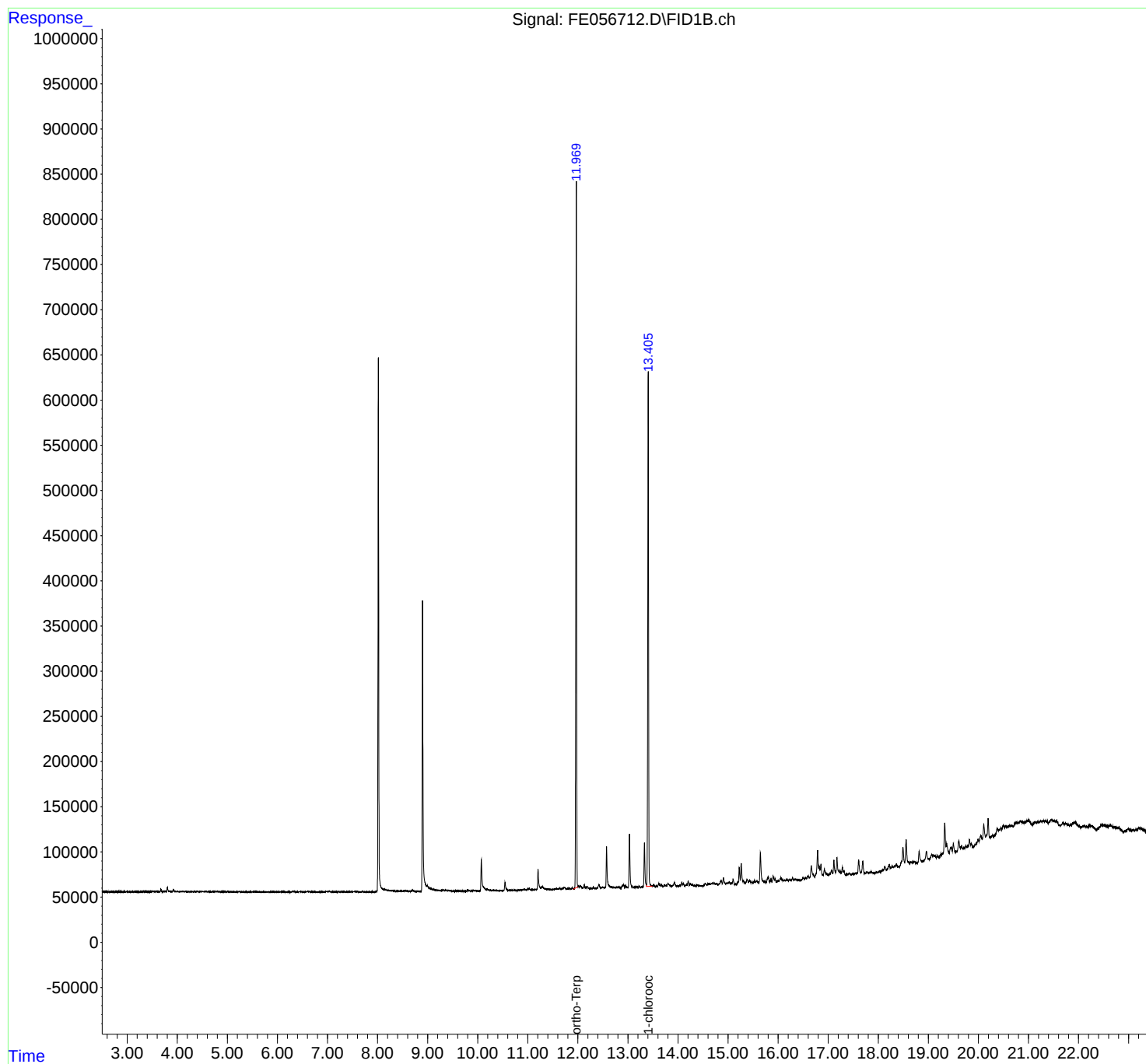

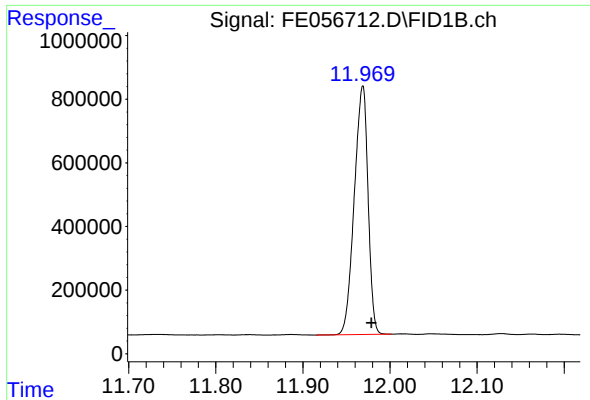

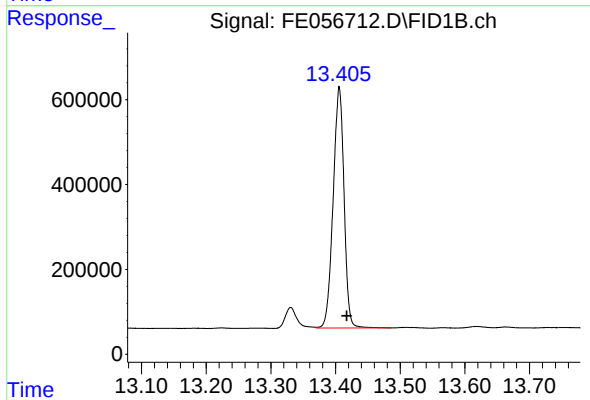




#9 ortho-Terphenyl (SURR)
