For samples 4-9 only a Terracore kit was received. Please note the lab can only run GRO from this. There is not enough volume to analyze for TPH_DRO or to send out for TOX. TPH-DRO, GRO, and TOX need at least two 8oz jars per sample of volume in order to run analysis.
