### A. Number of Samples and Date of Receipt:

1 Solid sample was received on 07/26/2022.

#### **B.** Parameters

According to the Chain of Custody document, the following analyses were requested: Ignitability, PCB, pH, TCLP Extraction, TCLP ICP Metals, TCLP Mercury, TCLP METALS, TPH GC and VOC-TCLVOA-10. This data package contains results for TPH GC.

### C. Analytical Techniques:

The analysis were performed on instrument FID E. The column is RXI-1MS which is 20 meters, 0.18mm ID, 0.18 um df, catalog 10224. The analysis of TPH GC was based on method 8015D and extraction was done based on method 3541.

## D. QA/ QC Samples:

The Holding Times were met for all analysis.

The Surrogate recoveries met the acceptable criteria except for

METRO-DISP [TETRACOSANE-d50 - 0%],

METRO-DISPMS [TETRACOSANE-d50 - 262%] and

METRO-DISPMSD [TETRACOSANE-d50 - 307%].

The Retention Times were acceptable for all samples except for METRO-DISP.

The MS {N3914-01MS} with File ID: FE036761.D recoveries met the requirements for all compounds except for Petroleum Hydrocarbons[220%] due to matrix interference. The MSD {N3914-01MSD} with File ID: FE036762.D recoveries met the acceptable requirements except for Petroleum Hydrocarbons[367%] due to matrix interference.

The RPD for {N3914-01MSD} with File ID: FE036762.D met criteria except for Petroleum Hydrocarbons[49.9%] due to matrix interference.

The Blank Spike met requirements for all samples.

The Blank analysis did not indicate the presence of lab contamination.

The Initial Calibration met the requirements.

The Continuous Calibration met the requirements.

Sample METRO-DISP was diluted due to high concentration.

# E. Additional Comments:

The soil samples results are based on a dry weight basis.

Sample METRO-DISP original run reported as screening Data.
