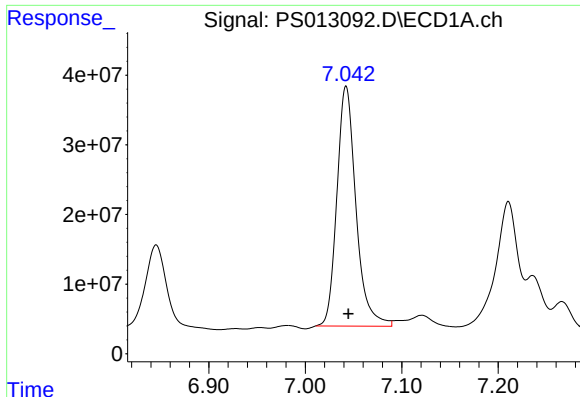
#2 3,5-DICHLOROBENZOIC ACID

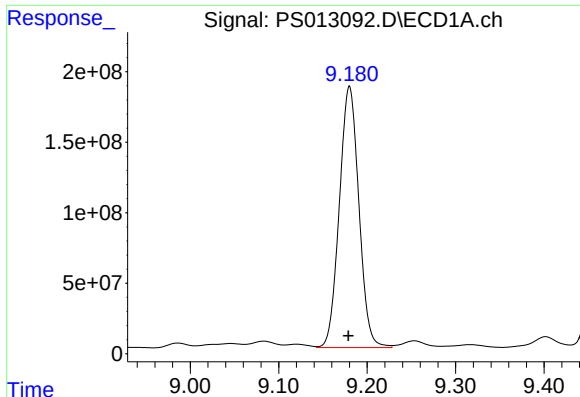
#10 Pentachlorophenol
