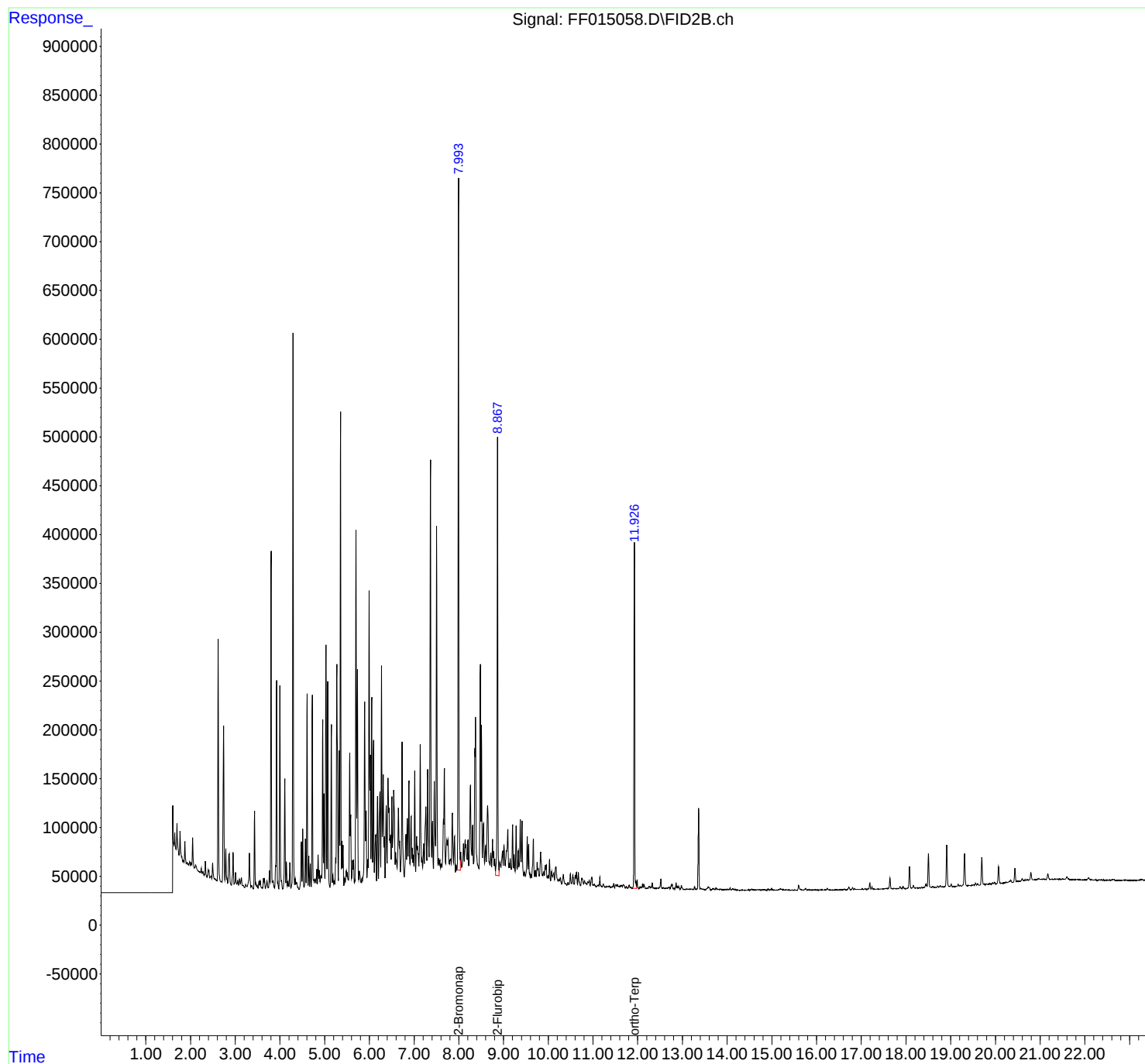

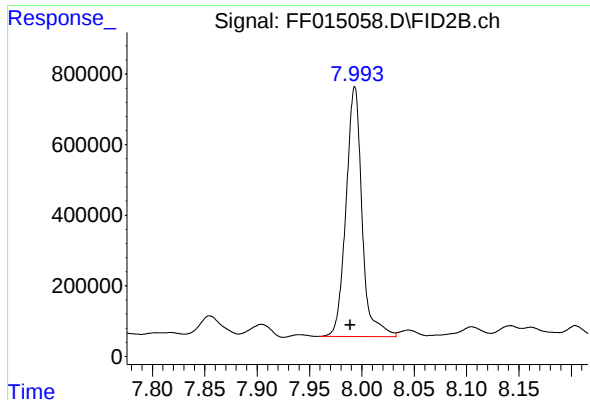

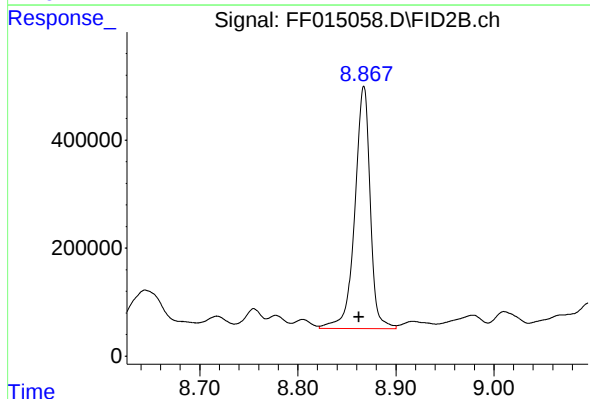




#4 2-Bromonaphthalene (SURR)

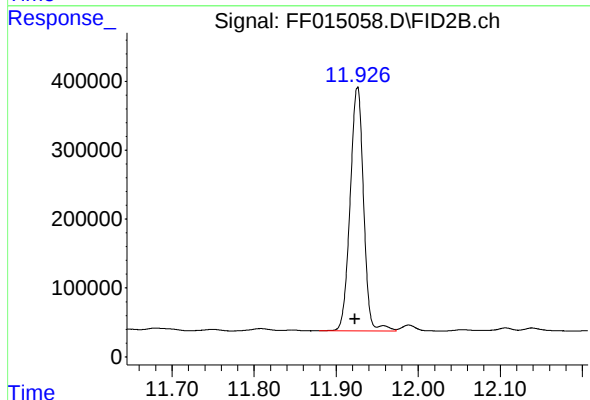
