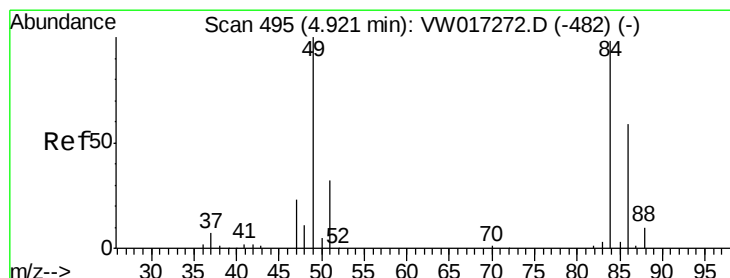
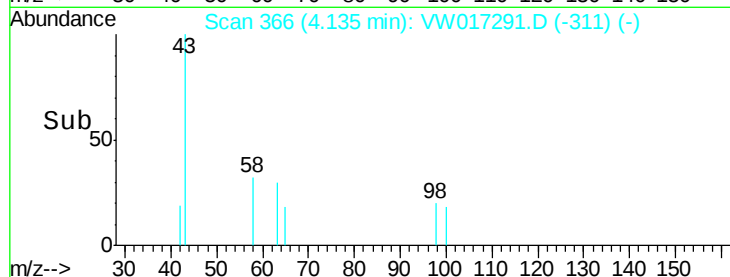


Abundance Ion 43.00 (42.70 to 43.70): VW
